### **Special Guest Speaker — LSSSRA President, Lee Simpson**

Lee Simpson provided an update on the situation. We are still in a waiting game, and Lee encouraged us all to join the LSSSRA to strengthen our case for the need for a full impact environmental assessment. There is strength in numbers. There are now over 1,000 LSSSRA members and we would like to see that number grow. Their position is simply that before any approval of a fixed link bridge, there must be a full impact environmental assessment. Additionally, less costly alternatives must be explored. The Ferry is not at the end of its life, contrary to the “story” that is being told. It has a number of years left in it. There are more environmentally friendly ferries if there is a desire to replace it. And their cost would be a very small fraction of the cost of a fixed link bridge, which is now closer to \$800 Million!! Lee encouraged us to continue to share his regular detailed electronic updates and we agreed to continue to share them with our community and post them on the McRae Beach website.
